- (ii) The work shall be executed as per CPWD specification 1996 Vol-I to VI with correction slips issued up to the date and as per direction of Engineer – in – charge.
- (iii) The contractor shall take all safety measures for satisfactory completion of the work at his own cost and he shall be completely responsible for any mishap that may occur during execution of the work.
- (iv) No T & P will be provided by the DTC.
- (v) All valid/mandatory taxes will be deducted as per Govt. rules from contractor bill.
- (vi) Any damage to any part of the building during execution of the work shall be made good by the contractor at his own cost.
- (vii) The percentage rates quoted by the contractor includes cost of royalty, octroi, local taxes, cartage, labour, material etc. and all other inputs involved for satisfactory execution of the work/item.
- (viii) The contractor shall make his own arrangement for filtered & unfiltered water for use in construction and for his labour.
